7. The bids (e-bid and hardcopy) will be opened in the presence of Bidders representatives who choose to attend at **08-01-2019 (2075-09-24) 13:00** hours at the office of Office of Resunga Municipality, Gulmi, Nepal.
8. Bids must be valid for a period of **90 of days after bid opening** and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting as specified above which shall be valid for **30 days beyond the validity period of the bid**.
