2. Bidding is open to all eligible bidders. Office of Resunga Municipality, Gulmi invites electronic bids from eligible bidders for the works under National Competitive Bidding.

5. Pre-bid meeting shall be held at Office of Resunga Municipality, Gulmi at 2019-11-20 (2076-08-04) 11:00 hours.
6. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 2019-12-01 (2076-08-15) 12:00 hours. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2019-12-01 (2076-08-15) 13:00 hours at the Office of Resunga Municipality, Gulmi. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting as shown in Table below which shall be valid for 30 days beyond the validity period of the bid. i.e. 2020-03-29.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
