- 1. The Government of Nepal/Resunga Municipality has allocated funds to cover eligible payment under the Contract mentioned below. Bidding is open to all eligible Nepalese Bidders.
- 2. Office of Resunga Municipality invites electronic bids only from eligible bidders for the procurement of below mentioned Contract Works under procedures as mentioned.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Office of Resunga Municipality Office of Resunga Municipality, Gulmi, Nepal or may visit PPMO website www.bolpatra.gov.np/egp.
- 4. Bidding document is available online and can be downloaded from e-GP system http://www.bolpatra.gov.np/egp. Interested bidders should register in the e-GP system and deposit the cost of bidding document as mentioned in table below for each contracts mentioned below in the following specified bank details:

- 5. Pre-bid meeting shall be held at Office of Resunga Municipality (RMO), Gulmi, Nepal at 17-03-2019 (2075/12/03) 13:00 hours.
- 6. Interested bidders can purchase or should submit online bids through e-procurement portal http://www.bolpatra.gov.np/egp only on or before 27-03-2019 (2075-12-13) 12:00 hours. Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system. Online bids shall be opened in the presence of Bidders representatives who choose to attend in person on 27-03-2019 (2075-12-13) 13:00 hours at the office of RMO, Gulmi, Nepal.
- 7. Online bids for both contracts must be valid for a period of 90 days counting from the day of bid opening (i.e. at least upto 2019 June 24 or 2076 Ashadh09) and must be accompanied by bid security, amounting as mentioned below which shall be valid for minimum 30 days beyond the bid validity period (i.e. upto 2019 July24 or 2076 Shrawan08). The scanned copy of bid security and bank voucher of bid document cost deposit should be uploaded in the e-GP system in PDF format during bid submission.
- 8. If the office happens to be closed on the date of opening/purchasing/submission of the bids or pre bid meeting as specified, the next working day at the same time and venue shall be considered as the required date and in this case Bid security validity and Bid validity remains same as mentioned above.
